However, in order to save the educational and other institutions and scholars from scarcity of standard atlases and other publications of real worth, the Government have been releasing useful books and atlases etc. after blacking out the objectionable portions, Books and publications which contain serious and numerous mistakes incapable of being corrected without marring the usefulness of the publications are, however, not allowed to be imported into India. So far, 188 such books and publications have been allowed to be imported after blacking out their objectionable contents,
