

**Automatic Telephone Exchange in Teretta Bazar, Calcutta**

Will the Minister of Communications be pleased to state:

(a) whether it is a fact that the proposal for setting up an automatic Telephone Exchange in the Teretta Bazar, Calcutta was sanctioned in 1962 but even the construction of the building for the Exchange has not yet started; and

(b) if so, the reasons therefor?

**The Minister of State in the Departments of Parliamentary Affairs and Communications (Shri Jaganath Rao):**

(a) Yes.

(b) Building drawings are prepared after approval of the scheme and after taking possession of the land. In this case the land had to be purchased in two parts which took about three years. The second part of the land was taken over on 9-11-65. The work for the preparation of building drawings had been entrusted to private Architect and the building drawings have been finalised.

A 13 storeyed building costing about 1.5 crores has been designed for the proposed exchange. Financial sanction for this building is being obtained. Installation of the automatic exchange will be commenced after completion of building.
