Out of the total grant of Rs, 19.02 lakhs sanctioned to the University of Kerala by the University Grants Commission during 1965-66, an amount of Rs. 15.37 lakhs was paid to the University during that year. The grants which could not be paid to the University by the end of the last financial year would not lapse till a period of one year from the issue of the sanction letters.
