## Nagaland Assam Boundaries

2746. Shri Firodia: Will the Minister of Home Affairs be pleased to state:

- (a) whether Government have instituted an enquiry to find out whether or not the Nagas have occupied several thousands acres of land in Assam; and
- (b) if so, the results thereof? 2301 (Ai) LSD-6.

The Deputy Minister in the Ministry of Home Affairs (Shri Vidya Charan Shukla): (a) and (b). Enquiries were made in the matter from the Governments of Assam and Nagaland. According to the Government of Assam, about 6000 acres of reserve forests in Assam have been encroached upon by Nagas but according to the Government of Nagaland, certain areas which have been under cultivation by Nagas since long are now being claimed by the Government of Assam. As stated in reply to the Unstarred Question No. 139 in the Lok Sabha on 2-11-66, the Chief Minister, Nagaland, has written to the Prime Minister, inviting attention to this matter and suggesting the appointment of a boundary commission. This matter is under consideration.
