**Transfer of I. A. C. Staff from Calcutta to Gauhati and vice versa**

6890. SHRI BISWANARAYAN SHASTRI : Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state :

(a) the total expenditure incurred by the Indian Airlines Corporation on account of transfer of staff from Calcutta to Gauhati and *vice versa* during the year 1968-69 ; and

(b) the reason for frequent transfers ?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) : (a) and (b). The total expenditure on this account is Rs. 22,237.63 out of which a sum of Rs. 14,936.50 is on movement of Engineers due to operational requirements. The balance of Rs. 7,301.13 is spent in line with the normal transfer policy for Gauhati station, evolved in consultation with Workers Unions, and includes temporary transfers as leave replacement of technical personnel.

**Cultural Activities between India and Soviet Union**

6891. SHRI BENI SHANKER SHARMA : Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state :

(a) whether the Soviet Minister of Culture, Madame Furtseva, has suggested that there should be greater dissemination of information about the activities

of people who returned after training in music, dance and other cultural activities in each other's countries and ways and means should be devised to bring the cultures of the two countries to the masses ;

(b) whether the need for greater exchange of films was also emphasised ; and

(c) if so, the action proposed to be taken in the matter ?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (DR. V. K. R. V. RAO) : (a) and (b). Yes, Sir.

(c) Such exchanges from the subject matter of the Cultural Exchange Programme agreed to after discussions between the representatives of the Indian and Soviet sides. Every year efforts are made to increase cultural activities in the succeeding years. Follow-up, wherever possible is ensured by suitable Agencies, if they exist, or by Government.

**Appointment of West German Firm as Consultant for setting up Hotels**

(a) whether it is a fact that Government propose to appoint as their Consultant a West German firm which runs a chain of hotels ;

(b) whether it is also a fact that Government have offered to build hotels in the neighbouring countries ; and

(c) if so, the details thereof ?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH) : (a) and (c). Government are working out some proposals for co-operation with the Government of West Germany for the development of Tourism in India including a consultancy service for the improvement of Public Sector hotels.

**Memorandum from Students of Technical Training Centre, Kota (Rajasthan)**

6894. SHRI MADHU LIMAYE : Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state :

(a) whether Government have received any memorandum from the students of the Technical Training Centre (Kota) with a covering letter dated the 22nd March, 1969 from an M. P. ;

(b) if so, what are the main points of the memorandum ; and

(c) what action Government has taken to so revise the Scheme so that the students get real and useful practical training and the nation derives lasting benefit from the Scheme ?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (DR. V. K. R. V. RAO) : (a) Yes, Sir.

(b) The main complaint of the students is that the programme of training at the Kota Centre does not give adequate practical experience, and that it is more theoretical.

(c) An Officer of the Ministry of Education and Youth Services and another officer of the Ministry of Irrigation and Power have visited the Training Centre and reported that the programme of training has been designed on the best lines possible, and is devoted mainly to practical work. The complaint of the trainees is unjustified.
