Railway Line from Adilabad (South Central Railway) to Rajpura Manikgarh

4099. SHRI GANGA REDDY: Will the Minister of RAILWAYS be pleased to state:

- (a) whether he is aware that there was a scheme to extend the Railway line from Adilabad (South Central Railway) in Andhra Pradesh up to Rajpura Manikgarh, situated in the erstwhile Hyderabad State, and whether some survey had also been n:ade;
- (b) whether Government have any proposal to extend this line and connect it to Madras-Delhi line and, if so, when it will be taken up; and

THE MINISTER OF RAILWAYS (DR. RAM SUBHAG SINGH): (a) No surveys had been carried out in the past for the construction of a new line from Adilabad to Manikgarh. However, Traffic investigations carried out in 1929 for the extension of the Majri (on the Madras-Delhi trunk route) Rajpur line up to Adilabad had indicated that the return from such a line would be poor.
