Import of Raw Materials by State Trading Corporation

4257. SHRI YASHPAL SINGH. Will the Minister of FOREIGN TRADE AND SUPPLY be pleased to state:

- (a) whether Government propose to channelise the import of raw materials through the State Trading Corporation; and
- (b) if so, whether the views of the Foreign Trade Board would be obtained before implementing the decision?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (SHRI CHOWDHARY RAM SEWAK): (a) and (b). It is proposed to expand progressively the scope of the activities of the State Trading Corporation in the field of import of essential raw materials.

The matter was discussed at the meeting of the Board of Trade held in January, 1969. The views expressed by some members on this question have been noted.

- (b) whether it is also a fact that the decline in export is due to inferior quality of wigs, if so, the rate of fall in export of wigs and the loss in foreign exchange during the last two years;
- (c) the steps being taken to improve the quality of wigs and to step up its export;
- (d) whether it is further a fact that wig factory Madras is overstaffed in relation to its productivity; and
- (e) the present rate of production of the factory and comparative

figures for the last year and the amount of foreign exchange earned by way of exports of its products annually?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE AND SUPPLY (SHRI CHOWDHARY RAM SEWAK): (a) Yes, Sir.

- (b) and (c). No, Sir. The quality of wigs produced by Wig India has been acceptable to foreign buyers. Suitable adjustments in production are also being made from time to time, to keep in line with the changing trends in fashions.
- (d). Yes, Sir. However, with the improvement in the marketing arrangements for the export of wigs and other hair products, the labour force is expected to be fully utilized. The surplus force is being diverted for manufacturing eye-lashes.
