THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI JAGANNATH RAO):

- (b) Subsequent to the receipt of the recommendations of the Administrative Reforms Commission, the services of only one officer and 4 security guards have been obtained on deputation, for Khetri Copper Project, as their work was of a specialised nature. The total number of deputationists in Khetri Copper Project is only 21.
- (c) and (d). A statement showing details of all employees at present on deputation in Khetri Copper Project is laid on the Table of the House. [Placed in Library. See No. L.T.—2464/69]. The Khetri Copper Project is taking steps to reduce its dependence on deputationists.
