certain investigations on 'Akashbel' or 'Amarvel' (Cascuta reflexa Roxb). No anti-cancer activity could be found. Further investigation was dropped.

The Cancer Research Institute, Tata Memorial Centre, Bombay also tested the extracts of this plant against the transplantable tumours L1210 and P 388 and found that it was inactive against both the tumour systems.

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING, AND WORKS, HOUSING AND URBAN DEVELOP-MENT (SHRI B. S. MURTHY) : (a) Central assistance to the State is given in the form of block loans and block grants and it is for the State Governments to allocate funds for the various Plan Schemes. However, an outlay of Rs. 57:00 lakhs has been earmarked for Mysore State during the first year of the Fourth plan for Rural Water Supply Schemes.

(b) This will be known only after 31-3-1970 when the current financial year (i.e. the first year of the Fourth Plan) is over.

(b) Reserves of the order of 600 million tonnes of iron ore with average 58% FE and above have been proved in thirteen deposits in the area by the Geological Survey of India. Of these about 164 million tonnes of processed lumpy ore with 63% FE is likely to be recoverable from the hard ore zones of the deposits.
