Philips who have an industrial licence for the manufacture of 3600 amplifiers per annum at their Calcutta factory, are submitting production returns indicating production of this item in their Calcutta factory. The question whether these amplifiers are being produced in their Calcutta factory or elsewhere is being investigated.
