खाद्य, कृषि, सामुदायिक विकास तथा सहकार मंत्रालय में राज्य मंत्री (श्री अन्ना-साहिव शिन्दे) : (क) तथा (ख). छोटे किसान की समस्याओं को हल करने के लिए वित्तीय सलाहकार सेवा स्थापित करने का कोई विचार नहीं है। फिर भी, छोटे किसानों की समस्याओं का अध्ययन करने और उनका हल ढूढने के लिए "छोटे किसानों के विकास अभिकरणों" की स्थापना हेतु एक मार्गदर्शी योजना शुरू की जा रही है। योजना की मुख्य विशेषतायें पहले ही 20 नवम्बर, 1969 को अतारांकित प्रश्न संख्या 694 के उत्तर में बना दी गयी हैं।

Construction of Tubewells In Jalore District, Rajasthan

1618. SHRI D.N. PATODIA : Will the Minister of FOOD AND AGRICULTURE be pleased to state :

(a) whether the scheme for construction of 200 tubewells In Jalore district of Rajasthan was transferred by the Central Government to be further explored by UNDP ; if so, when the project was entrusted to UNDP ; what progress has so far been made ; what are the reports received and by what time the job will be completed ;

(b) whether no tubewells have so far been constructed even on those sites which were found to be suitable ; if so, the reasons thereof ;

(c) whether underground water reserve is available in plenty in Jalore district and if properly exploited, the district will be converted from the deficit to a surplus area ; and

(d) what is the total estimated cost for construction of tubewells in the district ; and in view of the cost being very modest, what are the reasons for delay in implementing the project ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE, COMMUNITY DEVELOPMENT & CO-OPERATION (SHRI ANNASAHIB

SHINDE) : (a) No. The Exploratory Tube-wells Organisation of the Government of India has undertaken a project for the assessment of groundwater resources in Western Rajasthan with the technical and financial assistance of the UNDP (SF). The Jalore district is included in the area covered by the Project. The work in the Jalore area started in December, 1966. The geological field work and drilling work have been completed ; recording of hydro-meteorological data, collection of surface irrigation data and data on cropping pattern in the area is in progress. The Project is likely to be completed by the end of 1970.

(b) to (d). Investigations under the UNDP (SF) Project in Jalore area would not be over till the end of 1969. However, preliminary observations have revealed that in certain parts of Jalore over-pumping has fall already taken place with a consequent in the water table and symptoms of infestation of fresh water with saline water have appeared. It is, therefore, not at all advisable to undertake any programme of construction of tubewells even on a limited scale in Jalore area till all the relevant data about the aquifers has been collected and interpreted. It is only after the feasibility of constructing tubewells in Jalore district has been established on the basis of scientific data that any programme of construction of tubewells in the area can be constructed.
