respectively, for selections of some candidates for appintment on *ad hoc* basis, as Field Publicity Officers. These appointment were proposed to be offered for a temporary period pending oppointment, on regular basis, of candidates recommended by the Union Public Service Commission as per rules.

In the meantime, an open competition was held by the U. P. S. C. in April 1969 for recruitment to Grade IV of the Central Information Service, to select candidates for appointment as Field Publicity officers and to other posts. Action for appointment of Field Publicity Officers on *ad hoc* basis was not, therefore, proceeded with.

Top-Ranking Carnatic Musicians in India

Selection of Artistes for National Programme (Karnatic Music)

Only those artists who are graded 'A' and 'Top ranking' are generally booked for National Programme. Selection is made by music experts in the DG AIR on the advice of the Chief Producer in consultation with the Heads of Stations concerned. The grading, the present qualities of performance and the age of the artists are important factors which are taken into account while making the selection.
