The Minister of State in the Ministry of Health and Family Planning, and Works, Housing and Urban Development (Shri B. S. Murthy): (a) and (b). The allergic reaction of penicillin in the human body was already known. Instructions had already been issued to the effect that all patients requiring penicillin injections and who have not had such injections before, were given a skin sensitivity test before administering injections. The Medical Officers have also been instructed that injections of penicillin should not be administered without anti-histamines, adronalin and stimulants for parenteral use being kept immediately handy.

(c) No such statistics have been maintained.

Chavan): The new scheme introduced by the Indian Oil Corporation from November 24, 1969 for awarding dealerships for pumps, Kerosene, LDO, and Indane Gas to unemployed local young engineering and other graduates coming from the low income group families provides for weightage for members, of the Scheduled Caste and Scheduled Tribes.
