former Inspector General of Police, Andhra Pradesh, Shri Nambiar, has since been completed; and

(b) if so, the findings thereof and the action taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA) : (a) Yes, Sir.

(b) The enquiry related to the former I.G. Police and certain other officials of Andhra Pradesh. The report of the C.B.I. is under consideration of the Government of Andhra Pradesh who are primarily concerned with the matter and who are the competent authority under the rules to initiate appropriate action. It may prejudice consideration of the matter if the contents of the report are divulged at this stage.

#### Admission in Delhi University of Students Getting less than 40 Per Cent Marks in Higher Secondary Examination

3751. SHRI MANIBHAI J. PATEL: Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state :

(a) whether a decision has been taken by the Delhi University that the students securing less than 40 per cent marks in the Higher Secondary Examination should not be admitted to the University courses; and

(b) if so, the alternative proposals considered by Government for all those students who would get less than 40 per cent marks?

THE MINISTER OF EDUCATION AND YOUTH SERVICES (Dr. V.K.R.V. RAO): (a) and (b). The University has decided that the minimum eligibility condition will be that a candidate should have secured in the Higher Secondary Examination not less than 40% marks for admission to Pass courses in Aits and Commerce and not less than 45% marks for admission to Pass courses in Science.

There are other avenues open to candidates who are unable to get admission such as Correspondence Courses of the Delhi University and the courses at the Industrial Training Institutes.

(b) whether Government have obtained the post mortem report and the findings of the inquiry and are satisfied that the nature of the injurles on the body were caused by the deceased having been caught in the belting of the shaft of the machine; and

(b) whether the post mortem report shows that the body of the deceased had been torn off our pulped as is usual in such accidents?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) No, Sir, The Magisterial enquiry was conducted by Sub-Divisional Magistrate, Dehra.

(b) and (c). The Government of Himhchal Pradesh had received the post mortem report earlier and also the findings of the Magisterial enquiry now and had
