THE DEPUTY MINISTER IN THE MINISTERY OF INDUSTRIAL DEVE-LOPMENT AND INTERNAL TRADE (SHRI M.R. KRISHNA): (a) Three during the last two years. Foreign exchange worth Rs. 20.132.

(b) The visits of Managing Director, Hindustan Machine Tools, Banglore abroad during the last two years namely 1968-69 and 1969-70 were primarily for negotiating sales agency agreements with parties in the foreign countries for promoting exports of the Company's products and for negotiating collaboration agreement to take up manufacture of sophisticated items of equipment. He had finalised sales agency and collaboration agreements with parties in U. S. A., Cabada, U. K., West Germany, France and Switzerland. As the Chief Indian

delegate nominated by Government, he visited Hongkong and Tokyo and participated in the Asian Productivity Symposium and took the opportunity to visit the neighbouring countries to explore export market prospects for the Company's products.

(c) The visits abroad of the Managing Director are undertaken only when they are inescapable and the need for maintaining austerity is always kept in view.

Loss to H. M. T. Due to Purchase of Lead and Copper at Higher Rates
