Estt (D) dated the 30th August, 1969 had mentioned in para 2 that the 'size and number of Departmental Promotion Committee (S) should be decided by each Ministry/Department. There is a common Ministerial cadre, for the Institute as well as for the Regional Research Stations and the other Research Stations, it was experienced that when there was a number of vacancies and the zone of consideration of the candidates from the seniority lists was very large it would involve the association of almost all the Heads of Offices numbering more than 30 on the Departmental Promotion Committee. This, obviously, besides being unworkable would involve waste of time of scientists. The CAO-cum-Registrar is the Reviewing Officer for the work of the Head Clerks and the Superintendent Grade II in the Ministerial Class III posts. It was, there fore, felt that his inclusion in the Departmental Promotion Committee as Chairman fully complied with the instructions contained in the 47th Report of the Estimates Committee embodied in the orders of the Home Ministry referred to above, Further, the Departmental Promotion Committee assesses the suitablity of a candidate strictly on the basis of the Confidential reports: on the work and the conduct of a staff member given by the respective Head of the Division/Officer in-charge under whom the assessee worked and which is reviewed by the CAO-cum Registrar. However, even so the Head of the Division in whose Division a vacancy arise, is now associated as member of the Departmental Promotion Committee as mentioned above. Even here: with a view to giving a sense of participation it is the Divisional Head under whom the vacancy occurs that is material and not under whom the Head Clerks have worked.

## भिण्ड तथा इटावा के बीच सीघी टेलीफोन व्यवस्था

3275. श्री यशवन्त सिंह कुझवाह: क्या सूचन: तथा प्रसारण और संचार मंत्री यह बताने कि कृपा करेंगे की भिण्ड (मध्य प्रदेश) और इटावा (उत्तर प्रदेश) के बीच सीघी टेलीफोन व्यवस्था अत्रम्म करने की पहले से ही स्वीकृत योजना के बारे में अब तक कितनी प्रगति हई है ?

सूचना तथा प्रसारण मंत्रालय और संचार विभाग में राज्य मंत्री (श्री शेर सिंह) : भिंड और डटावा को जोड़ने वाली एक सीधी ट्रंक लाइन की व्यवस्था करने की स्वीकृति दे दी गई है । इन दोनों स्थानों के बीच उपभोक्ता ट्रंक डार्यालग चालू करने का ग्रामी कोई प्रस्ताव नहीं हैक्योंकि ट्रंक ट्रेफिक के ग्राधार पर ऐसा उचित नहीं ठहरता ।

सीघी लाइन लगाने के प्राक्तलन तैयार कर लिए गये हैं क्रोर इनकी मंजूरी दी जा चुकी है। इसका निर्माण करने के लिए आवश्यक मिंहार और सामान इकट्ठा किया जा रहा है। क्योंकि कई मदों की सप्लाई बहुत ही कम है, इसलिए इस काम में विलम्ब होने की संमावना है।

# त्रि-स्तरीय पंचायतो राज-प्रणाली आरम्भ करना

3276. श्री यशवन्त सिंह कुशवाह : क्या साद्य तथा कृषि मंत्री यह बताने की कृपा करेंगे कि देश में त्रिस्तरिय पंचायती-राज प्रणाली आरम्म करने के सम्बन्ध में की गई कार्यवाही का ब्योरा क्या है ?

साध, कृषि, सामदायिक] विकास तथा सहकारित मंत्रालय में उप मंत्री (श्री स. च. जमीर) : केन्द्रीय सरकार राज्य सर-कारों से इस बात के लिए लगातार आग्रह करती रही है कि पंचायती राज कार्यक्रम को शीघ्र लागू करने की आवश्यकता है। सामु-दायिक विकास और पंचायती राज सम्बम्धी नीती विषयक पहुंच पर पिछली बार जून, 1968 में मद्रास में हुए राज्यों के मुख्य मंत्रियों और सामुदायिक विकास और पंचायती राज के प्रमारी मंत्रियों के सम्मेलन में विचार-विमर्श किया गया था। सम्मेलन ने सिफारिश की थी कि लोकतंत्रीय विकेन्द्री-करण के उपकरणरूप में पंचायती राज चालू रहना चाहिये और तीन स्तरीय मयवा दो स्त रीय ढांचेसे सम्वन्धित प्रश्न राज्य सरकारों की मर्जी पर छोड़ दिया जाना चाहिए । पंचायती राज ढांचे से सम्बन्धित राज्यवार स्थिति दर्शाने वाला एक विवरण समा पलट पर रखा गया है । [ग्रन्थाल्य में रखा गया । देखिये संख्या LT-4479 / 701

#### Working of Aaralem farm, Kerala

3277. SHRI E. K. NAYANAR: Will the Minister of FOOD AND AGRI-CULTURE be pleased to state :

(a) the details of working of Aaralem Farm set up with the aid of Soviet Union in the Kerala State; and

(b) Whether the work of the farm will begin before the end of this year ?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD, AGRICULTURE COMMUNITY DEVELOPMENT AND COOPERATION (SHRI ANNASAHIB SHINDE): (a) The Central State farm being set up in the Cannanore district of Kerala will have a total area of about 4,800 hectares. The area so far taken over is about 2,980 hectares. Action for acquiring the remaining land is being taken by the Government of Kerala.

(b) No Sir. Proceeding with regard to compensation for trees standing on the acquired land are still pending in the law courts and it is, therefore, not possible to do jungle clearance work on the land already acquired. The machinery for the farm has started coming and some of it has already reached Cannanore. A part of the land has no jungle growth and cultivation operations on that part of the land are expected to start early next year.

#### Representation of Kerala Film Chamber of Commerce on All India Film Council

3278. SHRI E. K. NAYANAR : Will the Minister of INFORMATION AMD BROADCASTING AND COM-MUNICATIONS be pleased to state :

(a) whether Government have received any Resolution from the Keral Film Chamber of Commerce Executive Committee, which was passed on 26th August, 1970, demanding the Chamber's representation in the All India Film Council; and

(b) if so, the reaction of Government therero ?

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DE PARTMENT OF COMMUNICATIONS (SHRI I. K. GUJRAL) : (a) Yes, Sir.

(b) The request of the Kerala Film Chamber of Commerce will be taken into consideration while taking a final decision on the establishment and composition of the Film Council.

### Representation for Automatic Telephone Exchange at Ludhiana

3279. SHRIMATI NIRLEP KAUR : Will the Minister of INFORMATION AND BROADCASTING AND COMMU-NICATIONS be pleased to state :

(a) whether his Ministry has received representation from industrialists of Ludhiana for an automatic telephone exchange for the town;

(b) whether the new building for the automatic exchange was completed about 2 years ago, but the equipment meant for the automatic exchange was removed from Ludhiana to Rohtak; and

(c) if so the reasons for giving preference to Rohtak over Ludhiana

THE MINISTER OF STATE IN THE MINISTRY OF INFORMATION AND BROADCASTING AND IN THE DEPARTMENT OF COMMUNICA-TIONS (SHRI SHER SINGH) : (a) Yes.

(b) It is wholly incorrect and no equipment has been removed to Rohtak from Ludhiana. Building for the automatic exchange at Ludhiana was completed in July 1969.

(c) Question does not arise.
