Payment of Income Tax by Firms and Individuals in Mysore

3345. SHRI N. SHIVAPPA: Will the Minister of FINANCE be pleased to state:

- (a) the names of the top individuals and firms who pay the highest amount of income tax in Mysore State together with the amount of income assessed and the tax paid in each case during the last two years;
- (b) the amount of Income tax arrears of these individuals and firms as on the 31st March, 1970; and
- (c) the steps Government propose to take to recover it?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI VIDYA CHARAN SHUKLA): (a) to (c). The requisite information regarding 10 top individuals and firms who are assessed on the highest total income during the financial year 1969-70 is being collected and will be laid on the Table of the House as early as possible.

Withdrawal of Participants from Shooting Championship at Phoenix

3346. SHRI N. SHIVAPPA: Will the Minister of EDUCATION AND YOUTH SERVICES be pleased to state:

- (a) whether it is a fact that his Ministry's decision to withdraw from participation in shooting championship at Phoenix (USA) was due to the participation of South Africa; and
- (b) if so, whether Indian Government took steps to mobilise its opinion in International Olympic Committee against apartheid policy of South Africa?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION AND YOUTH SERVICES (SHRI BHAKT DARSHAN): (a) Yes, Sir. This Ministry gave this advice to the National Rifle Association of India.

(b) It is for the Indian Olympic Association, who are affiliated to the International Olympic Committee to take necessary steps in this regard. However, as and when the situation warrants, suitable advice is tendered to the Indian Olympic Association.

Loans provided to big Industrialists

3347. SHRI N. SHIVAPPA: Will the Minister of FINANCE be pleased to state the amount of loans given to big industrialists and traders after the nationalisation of Banks, State-wise?

THE MINISTER OF FINANCE (SHRI Y. B. CHAVAN): It is presumed that 'big industrialists' refer to 75 business houses/ groups mentioned in the Monopolies Enquiry Commission report. The aggregate amount of outstanding credit given by the 14 nationalised banks to 71 out of the 75 business groups/houses referred to in the Monopolies Enquiry Commission Report stood at Rs. 440.28 crores and Rs. 438.08 crores on 18-7-69 and 31-12-69 respectively. Figures for later dates are not available.

Figures of advances of nationalised banks to industry and trade State-wise also are not available.

Archaeological Finds Near Udipi in South Kanara District of Mysore

3348. SHRI S. A. AGADI: Will the Minister of EDUCATION AND YOUTH SERVICIS be pleased to state:

- (a) whether it is a fact that some Idols of Archa:ological importance belonging to IX and Xth Century Hoysala Period were found near Ucipi, South Kanara District of Mysore; if so the details of the findings;
- (b) whether there is a proposal that some of these findings be preserved in the National Museum, at New Delhi;
- (c) whether there is also a proposal to have a Hoysala period Museum at Hasan, Mysore State; and
- (d) if so, the details of the progress made in this direction?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION AND YOUTH SERVICES (SHRI BHAKT DARSHAN): (a) On the basis of some newspaper reports, the Superintending Archaeologist, Archaeological Survey of India, Southern Circle, Madras, was asked to report on the finds. He would be visiting the site this month, to assess their importance.

- (b) The question of preserving the finds at the National Museum, New Delhi, or another museum will arise only after their importance has been established.
- (c) and (d). Archaeological Museums are site Museums. The A:chaeological Survey of India has a Museum at Halebid. At present, there is no proposal to set up a Museum at Hasan.

Officials of Air India holding Foreign Passports

3349. SHRI S. A. AGADI: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether it is a fact that there are some officers in Air India who are holding foreign passports;
 - (b) if so, their number;
- (c) whether it is a fact that they were permitted to enange their nationality by the Indian Government; and
 - (d) if so, on what grounds?

THE MINISTER OF TOURISM AND CIVIL AVIATION (DR. KARAN SINGH);

(a) to (d). There are thirteen officers of Indian origin who hold foreign passports. Of these, eleven held such passports even prior to the nationalization of the airline in 1953. No permission was given to the other two for changing their nationality.

- (क) क्या सरकार का विचार मध्य प्रदेश के उज्जैन नगर में वीर दुर्गादास की मूर्ति पर लगे टूटे फूटे छत्न के नवीकरण के लिए कुछ मनुदान देने का है; क्रीर
- (ख) यदि हां, तो उक्त कार्य के लिए कितनी सहायता का प्रस्ताव है ?

शिक्षा तथा युवक सेवा मंद्रालय में राज्य मंत्री (श्री भवत वर्शन): (क) ग्रीर (ख). वीर दुर्गादास राठौर की मूर्ति, केन्द्रीय संरक्षित स्मारक नहीं है। इसलिए भारत सरकार, इसके परिक्षण और / मथवा ग्रनु-रक्षण के लिए जिम्मेदार नहीं है। सरकार को, इस स्मारक के नवीकरण के लिए ग्रनु-दान हेतु कोई ग्रनुरोध भी प्राप्त नहीं हुगा है।

क्या विक्त मंत्री यह बताने की कृपा करेंगे कि:

- (क) केन्द्रीय सरकार ने वित्तीय वर्ष 1970-71 में मध्य प्रदेश को अनुदान तथा ऋण के रूप में कितनी राशि देने का प्रस्ताव किया है; श्रीर
- (ख) ये ग्रनुदान तथा ऋण किन-किन कार्यों के लिए दिये जायेंगे ?

वित संतालय में राज्य संती (श्री विद्या-चरण शुक्ल): (क) स्रीर (ख). मध्य प्रदेश राज्य की 1970-71 की वार्षिक स्रायोजना के लिए 47.56 करोड़ रुपये की केन्द्रीय सहायता निर्घारित की गयी है। यह सहायता समग्र स्रायोजनागत व्यय के लिए इकट्ठे ऋणों स्रीर स्रनुदानों के रूप में, 70:30 के स्रनुपात में दी जायगी स्रीर इसका सम्बन्ध किसी खास योजना, प्रायोजना या विकास शीर्षक से नहीं होगा।
