The total cost of the future works included in the draft plans is estimated to be about Rs. 1,040 crores. Details, according to the category of works for such of the States for which the Plans have been prepared, are given in the statement laid on the Table of the House. [Placed in Library. See No. LT—4233/70]. The question of preparation of draft plans flood control and

drainage was reviewed at the Central Flood Control Board meeting held in 1968 and it was then decided that the States should revise the draft plans taking into account the experience of floods in recent years. After the draft plans are prepared these will be examined by the Technical Advisory Committees in the States and the State Flood control Boards and thereafter by the river Commissions and will have to be implemented as part of the developmental plans of the State Governments.
