Homoeopathic Dispensaries in Rural Areas

4510. SHRI N. SHIVAPPA : Will the Minister of HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT be pleased to state :

(a) whether the Central Government have issued directions to the States to open rural Homoeopathic Dispensaries; and

(b) if so, the reactions of State Governments thereto?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING AND WORKS, HOUSING AND URBAN DEVELOPMENT (SHR) B.+S. MURTHY) : (a) Health is a State subject. However, the various recommendations made by the Rural Homoeopathic Medical Aid Committee, including the one relating to the opening of Homoeopathic Dispensaries in rural areas, were brought to the notice of the State Gavernments/Union Territories for implementation.

(b) Most of the State Governments/ Union Territories have opened Homocopatic Dispensaries in their respective rural areas.

CHAVAN) : (a) No. The Oil & Natural Gas Commission and its subsidiary, Hydrocarbons India (P) Ltd. will continue to be entrusted with the responsibility for the work of offshore exploration for petroleum off the coast of India and Iran respectively.
