- 4513. श्री जगेश्वर यादव: पेटोलियम तथा रसायन ग्रीर लान तथा धात् मंत्री यह नताने की कृपा करेंगे कि :
- (क) क्या हाल ही में उत्तर प्रदेश के बांदा जिले में खनिजों के लिए सर्वेक्षरा किया गया था .
- (ख) यदि हां, तो सर्वेक्षरा के परिसाम-स्वरूप पाये गये खनिजों के क्या नाम है :
- (ग) क्या प्रत्युमिनियम ग्रादि जैसे कच्चे पदार्थभी वहाँ पाये गये हैं ; ग्रौर
- (घ) यदि हां, तो क्या इस पिछड़े हुये जिले में बेरोजगारी की समस्या की सुलभाने की बात को ध्यान में रखते हये सरकार का विचार वहां पर उपलब्ध कच्चे पदार्थों पर श्राधारित कोई उदयोग स्थापित करने का है ?

वेटोलियन तथा रसायन और खान तथा घात मंत्रालय में राज्य मंत्री (श्री नीतिराज सिंह चौघरी): (क) ग्रीर (ख). जी, हां। भारतीय भूवैज्ञानिक सर्वेक्षरा द्वारा किए गए सर्वेक्षण जो कि प्रगति पर हैं, के परिलाम-स्वरूर, प्रत्यमिनियम लैटराइट भीर बाक्साइट, डोमोमाइट, मिट्टी, ग्रगाटे, ग्लास-सैंड, गैरिक, फेल्डस्पार भीर वर्षाटज. जिप्सम, भलंकारिक प्रस्तर के निक्षप भीर प्राप्ति स्थल उवस्थित हुए हैं।

- (ग) बांदा जिले में बाइसाइट के लश्र निक्षेप (प्रव्यमिनियम का ग्रयस्क) उपलब्ध हैं।
- (घ) एक प्राइवेट कम्पनी द्वारा जिसे राज्य सरकार ने 1974 में पट्टा दिया था, क्षेत्र में बाक्साईट प्रशःक के बना का कार्य छोटे पैमाने पर प्रारम्भ किया गया है। विस्तत पूर्वेक्षण संक्रियाएं, जो उपलब्ध खनिज की श्रेणी में श्रीर कूल उपलभ्य राशियों को प्रतिपादित करने की दृष्टि से प्रगति पर हैं, के संपूरित हो जाने के उपरान्त ही, क्षेत्र में बाक्साइट निक्षेपों पर आधारित अल्युमिनियम प्रदानक को स्थापित करने के प्रकृत पर विचार किया जा सकता है।

### Shifting of Offices of National Mineral Development Corporation from New Delhi

#### SHRI D. N. DEB: 4514. SHRIN, K. SOMANI:

Will the Minister of PETROLEUM AND CHEMICALS AND MINES AND METALS be pleased to state:

- (a) whether offices of the National Mineral Development Corporation are proposed to be shifted from its present location in New Delhi;
- (b) the monthly rent being paid now and the additional liability per month where the offices are shifted to a new place; and
- (c) the reasons for incurring the additional expense?

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND SINGH METALS (SHRI NITIRAJ CHAUDHARY): (a) There is a proposal to move the head-quarters of National Mineral Development Corporation from its present location to another location in Delhi; the question of moving the headquarters out of Delhi, is also under consideration separately.

(b) and (c). The monthly rent being paid for the various premises presently occupied by National Mineral Development Corporation offices in New Delhi is Rs. 10,500/-. The additional liability on moving to the proposed centralised location would be Rs. 25,548/- per month. The present premises are considered insufficient and unsuitable due to increase in the projects assigned to the Corporation. The cost of moving the headquarters out of Delhi is yet to be worked out.

## Royalty Payable by Colliery Owners to West Bengal Government

THE MINISTER OF STATE IN THE OF **PETROLEUM** AND MINISTRY CHEMICALS. AND MINES AND METALS (SHRI SINGH NITIRAJ CHAUDHARY) : (a) to (c). The information is being collected and will be placed on the Table of the House.

### Scope for Economy Measures

- 4516. SHR1 MADHU LIMAYE: Will the Minister of DEFENCE be pleased to state:
- (a) whether the Staff Inspection Unit of the Ministry of Finance had assessed

the functioning of the Staff Inspection Unit, Department of Defence Production (DGI), DIGS, with a view to ascertaining the scope for economy measures;

- (b) whether this assessment has since been completed; and
  - (c) if so, the results thereof?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (DEFENCE PRODUCTION) (SHRI P. C. SETHI): (a) There is no Staff Inspection Unit of the Department of Defence Production (DGI), DI(GS). However the Staff Inspection Unit of the Ministry of Finance has recently assessed the Staff requirements of some of the establishments of the Directorate of Inspection (General Stores).

(b) and (c). The assessment of all the establishments taken up for examination by the Staff Inspection Unit has not yet been completed. But the Unit's recommendations in respect of a few of the establishments have been received and orders have been issued thereon, implementing the same.

### Loan to Central Government Employees for purchase of ready built houses

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING, AND WORKS, HOUSING AND URBAN DEVELOPMENT) (SHRIPARIMAL GHOSH): (a) The amount of
