**Meals served to students of Sainik School, Kunjpura**

4554. SHRI DINKAR DESAI : Will the Minister of DEFENCE be pleased to state :

(a) whether his attention has been drawn to the adverse comments about the meals served to the boys of the Sainik School, Kunjpura made by the Governor of Haryana when he visited the School on its Annual Day function held in October, 1970;

(b) if so, what steps have been taken by his Ministry to improve the diet of the boys;

(c) what was the amount per day per boy spent on diet when the school was opened in 1960 and the amount being spent now;

(d) the exact amount of milk, butter and eggs given per boy per day; and

(e) whether Government propose to appoint a Committee to suggest improvements in the diet of the boys of all the Sainik Schools in the country?

THE MINISTER OF DEFENCE (SHRI JAGJIWAN RAM) : (a) No, Sir. The Governor did not make any adverse comments.

(b) Does not arise.

(c) A sum of Rs. 1.80 was spent in 1961 per boy per day on diet. The amount spent now on diet per boy per day is Rs. 2.25.

(d) Quantity of milk etc., that are supplied to boys per day is as under:-

Milk—0.4 litre per boy per diem.

Butter—0.5 Oz per boy per week,

Eggs—3 to 4 eggs per week per boy.

(e) No, Sir. The question of a suitable increase in the *per capita* expenditure on diet is under consideration.
