THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND CHEMICALS AND MINES AND METALS (SHRI NITIKAJ SINGH CHAUDHARY):
(a) The National Mineral Development Corporation had requested the Govt. of Orissa for the grant of surface rights in the land lying on Orissa side at Hill-Top, which have been granted.

(b) and (c). Government of Orisa has not taken any steps to develop the

area so far. However, National Mineral Development Corporation has already constructed 60 Nos. Quarters and provided allied facilities.
