

**Current Situation in West Asia**

4478. **SHRI BAL RAJ MADHOK :**  
**SHRI K. M. MADHUKAR :**

Will the Minister of **EXTERNAL AFFAIRS** be pleased to state :

(a) whether the West Asian situation had undergone a big change following the death of President Nasser, Coup in Syria, direct talks between Israel and Jordan and the proposed Federation of UAR, Libya and Sudan;

(b) if so, whether Government have given a new look to its policy in regard to West Asia in the light of these developments; and

(c) if so, the reaction of Government to these changes and how these developments have affected our policy ?

**THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI SURENDRA PAL SINGH) :** (a) The recent developments in West Asia have not affected the basic prerequisite to peace in the region which is the withdrawal of the Israeli forces from the occupied Arab territories as required in the Security Council Resolution 242 of 22 November 1967.

(b) and (c). Firmly believing that the implementation of the Security Council Resolution is essential for the establishment of a just and lasting peace and reflecting her concern at the impasse that has been reached in relation to the implementation of this Resolution, India co-sponsored recently a Resolution in the UN General Assembly calling for early resumption of the Jarring Mission and the speedy implementation of the Security Council Resolution 242 of 22 November, 1967.
