THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (CHOWDHARY RAM SEWAK): (a) and (b). In December, 1968, Government of West Bengal was advised to set up a State Textile Corporation with a view to tackling the problem of sick textile mills in the State. The State Government intend to set up the proposed State Textile Corporation but they have not so far been able to arrange for the finances, required for the purpose.

Applications for age alteration by Judges of High Courts

(a) how many High Court Judges and from which High Courts, had applied during 1970 to get their ages altered ;

(b) and (c). The Judge has been requested to furnish documentary evidence in support of his claim. On receipt of such evidence a decision will be taken by the President in consultation with the Chief Justice of India as required under Article 217(3) of the Constitution. (d) Shri Justice Lehar Singh Mehta of the Rajasthan High Court.

(e) As stated in reply to (b) and (c) the matter is still under consideration.

Steamer Accommodation for the Coir Experts

(a) whether he has received any representation regarding difficulties experienced by the exporters of coir yarn and coir goods in getting Steamer accommodation; and
