# Exemption of Edible Oil Seeds from Storage Control Order

(d) if so, the details thereof, State-wise and the reaction of the Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF FOOD AND CONSUMER AFFAIRS (SHRI SATYA PAL SINGH YADAV): (a) and (b) Yes, Sir. This followed the commitment made in the Finance Minister's Budget Speech in 1997 to remove edible oilseeds and oils from the purview of the Storage Control Order. However, State Governments have been advised that they may enforce Storage Control for edible oils and edible oilseeds under the powers delegated to them under the Essential Commodities Act, 1955.

#### **Construction of Hospital Building**

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (DR. A.K. PATEL): (a) to (c) The State Government of Madhya Pradesh has informed that the Bhopal Memorial Hospital Trust has given administrative approval for the construction of miniunits (referral hospital) at Kotra Sultanabad for which land has been made available by the State Government.

# T.B. and other Diseases

3652. SHRI SOM MARANDI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) the percentage of people under poverty line and just above the poverty line are suffering from vulnerable diseases;

(b) the approximate fund is required to feed them adequately in order to prevent them from falling the victims of T.B. and other diseases;

(c) the total fund spent by the Centre and the State Governments for the treatment of T.B. and other diseases during the seventh and Eighth Five Year Plan;

(d) whether the Government propose to set up T.B. clinics in each district of the country;

(e) if so, the time by which these clinics are likely to be set up; and

(f) if not, the reasons thereof?

THE MINISTER OF STATE OF THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI DALIT EZHILMALAI): (a) No data in regard to percentage of people under the poverty line and just above the poverty line suffering from vulnerable diseases is reported under the programme.

(b) TB is caused by Tuberculosis bacilli and transmitted by infectious droplet from a diseased person to a healthy one when TB patient coughs or sneezes. Therefore, the only way to prevent spread of TB is to cure the sputum smear positive cases.

There has been substantial increase in the Budget provision for the National Tuberculosis Control Programme. Adequate funds have also been made available under the National Health Programme to combat the other diseases like Malaria, Filaria, Kalaazar, HIV/AIDS, Leprosy, Cancer and Iodine Deficiency disorder etc.

(c) During the Seventh and Eighth Five Year Plans, the funds Rs. 61.45 crores, and Rs. 131.18 crores respectively. The Central assistance provided during the Seventh and Eighth Plan periods for the control of vector borne diseases like Malaria, Filaria, and Kalaazar etc., is 425.23 crores and Rs. 591.06 crores respectively. The amount spent by the Government through the State Governments under National Leprosy Eradication Programme during the Seventh and Eighth Five year 'lans is Rs. 85.82 crores and Rs. 305.95 crores espectively. The National AIDS Control Programme was junched on 23rd September, 1992 and the amount spent y the Centre and States for AIDS Control Programme uring Eighth Plan was Rs. 274.26 crores. The xpenditure incurred under the 7th & 8th Five Year Plans nder the National Cancer Control Programme is s. 31.41 crores & Rs. 85.73 crores respectively.

(d) to (f) The National TB Control Programme is implemented through District TB Centres and TB Clinics. there are 446 Districts TB Centres in rural areas and 330 Chest Clinics in Metropolitan cities. It is proposed to set up the District TB centres in each district of the country by the end of the 9th Five Year Plan for which State have been requested.

### **Trade Union**

Amendments to the Trade Unions Act, 1926 are made keeping in view the requirements of the social partners and a cautious & pragmatic approach is adopted to ensure that the amendments take into consideration the requirements of the social partners as far as possible.
