Revenue Earned by Fertiliser Industry

3836. SHRIMATI SURYAKANTA PATIL: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (c) the details of the policy formulated by the Government to encourage fertiliser industry during 1998-99: and
- (d) the total value of the fertilizers produced till 31.10.98 as compared to the corresponding period of the last year?

THE MINISTER OF STATE IN THE MINISTRY OF CHEMICALS AND FERTILIZERS (DR. A.K. PATEL): (a) There is no excise duty on the fertilizers. The details of the corporate tax paid by the fertilisers companies are not available in the Department.

- (b) An amount of Rs. 6192.35 crore and Rs. 8617.93 crore was spent in 1996-97 and 1997-98 respectively on various schemes, such as Retention Price-cum-Subsidy Scheme, Scheme of Concessional Sale of Decontrolled P & K Fertilizers, Interest Concession Scheme, Import Substitution Incentive Scheme etc.
- (c) The following incentives are available for encouraging investment in fertilizer sector:-
 - (i) Normally no industrial licence is required for setting up a fertilizer plant.
 - (ii) Duty free import of capital goods for setting up of new plants/modernisation of existing units.
 - (iii) Deemed export benefits to indigenous suppliers of capital goods to fertilizer projects provided such supplies are made under the procedure of international competitive bidding.
 - (iv) Duty free import of fertilizer raw materials and intermediates.
 - (v) Reasonable return on investment to the entrepreneurs under the Retention Price-cum-Subsidy Scheme, at present applicable to urea.
 - (vi) Concession on decontrolled phosphatic and potassic fertilizers to promote the balanced use of nutrients.
- (d) The production of nitrogenous and phosphatic fertilizers during 1998-99 (till Oct '98) has been 59.08 LMT and 17.05 LMT, respectively as compared to 55.68 LMT and 17.00 LMT, during the corresponding period in 1997-98. Urea is sold at the statutory sale price fixed by the Government of India. Similarly, phosphatic and potasstic fertilizers are sold at the indicative sale price fixed by the Government.

The Government of India, Ministry of Agriculture have signed an agreement with the World Food Programme (WFP), for implementing a project titled-"Improvement of Food Security through Forestry Activities in Tribal Areas of Bihar, Orissa, Madhya Pradesh, Uttar Pradesh and Rajasthan".

The main objectives of the project are:-

- (i) To provide sustainable improvement in the target group's food security and income; and
- (ii) Empowerment of communities particularly women and households through participatory integrated rural development.

Under the Project, WFP will provide wheat (91355 MT), Rice (42600 MT), pulses (12560 MT) and Vegetable

Oils (3465 MT) with an estimated Food cost of US\$ 45.560 million over a period of five years for distribution at concessional prices to the daily wage labourers of the State Forest Department belonging to the most disadvantaged & poorest population.
