The Government of India, Ministry of Agriculture have signed an agreement with the World Food Programme (WFP), for implementing a project titled-"Improvement of Food Security through Forestry Activities in Tribal Areas of Bihar, Orissa, Madhya Pradesh, Uttar Pradesh and Rajasthan".

The main objectives of the project are:-

- (i) To provide sustainable improvement in the target group's food security and income; and
- (ii) Empowerment of communities particularly women and households through participatory integrated rural development.

Under the Project, WFP will provide wheat (91355 MT), Rice (42600 MT), pulses (12560 MT) and Vegetable

Oils (3465 MT) with an estimated Food cost of US\$ 45.560 million over a period of five years for distribution at concessional prices to the daily wage labourers of the State Forest Department belonging to the most disadvantaged & poorest population.

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS (SHRI SANTOSH KUMAR GANGWAR): (a) and (b) Yes, Sir. The details of new bottling plants planned in the State of Bihar are as under:

The cost of the bottling plants, yet to be firmed up, will depend on a number of factors like cost of land, type of land, quality of soil etc. The exact cost for such plants is evaluated after land approval and soil investigation etc.

- (c) As on 1.10.98, there were 100 LPG bottling plants of PSU Oil Companies operating in the country with a total capacity of 3795 TMTPA.
- (d) LPG Bottling Plants are constructed as per the existing National standards/statutory codes like OISD, Static and Mobile Pressure Vessels Rules, Gas Cylinder rules, Factory Act etc. to comply with the requirements of Safety and Welfare of the workers.
- (e) In view of deregulated scenario, economic viability of Haldigara LPG bottling plant is under study. It takes about 24 months for the construction of a LPG bottling plant after approval of its project report.
