#### Allotment of Salt Land

206. DR. SUBRAMANIAN SWAMY : Will the Minister of URBAN AFFAIRS AND EMPLOYMENT be pleased to state :

(b) if so, the details thereof; and

(c) if not, the reasons therefor?

#### Inclusion of OBCs

(d) if so, the reaction of the Government thereto?

THE MINISTER OF STATE OF THE MINISTRY OF SOCIAL JUSTICE AND EMPOWERMENT (SHRIMATI MANEKA GANDHI) : (a) and (b) Proposals for inclusion of castes/communities in the Central List of Other Backward Classes, including those from State Govts. are made to the National Commission for Backward Classes (NCBC) and on the basis of the advices of the Commission, Government notifies amendment in the Central List.

(c) No such recommendations have been received from the Government of Maharashtra.

(d) Does not arise.
