MURLI MANOHAR JOSHI): (a) to (e) According to the informtion furnished by Delhi Government, qualified Assistant teachers are given permission to prosecute higher studies like other teachers on their request provided the course of study is in line with the nature of their duties and such permission does not hinder the discharge of their duties. This facility has been available to such teachers in the past also.

According to guidelines issued by National Council for Teacher Education, full-time regular teachers of recognised schools with at least two years of teaching experience are eligible for admission to B.Ed. programme through distance education mode offered by a University in their area.

### Citizen Register Scheme

There is a proposal for compulsory registration of all citizens/non-citizens and to issue Identity Cards to all citizens of the age of 14 years and above. The details in this regard are being worked out. In addition, persons below 14 years are proposed to be compulsorily registered under the Registation of Births and Deaths Act, 1969.
