# LOK SABHA

Thursday, April 22 1999/Vaisakha 2, 1921 (Saka)

The Lok Sabha met at Eleven of the Clock

[MR. SPEAKER in the Chair]

[English]

DR. SUBRAMANIAN SWAMY (Madurai) : Sir, I have a point of order. I hope, I have your permission to raise a point of order. . . . (Interruptions)

SHRI R. MUTHIAH (Periyakulam) : I have given a notice. . . . (Interruptions)

DR. SUBRAMANIAN SWAMY : Sir, I hope, I have your permission.

MR. SPEAKER : What is your point of order ?

DR. SUBRAMANIAN SWAMY : My point of order is that when the debate was in progress on the Motion of Confidence. I had read out certain news items and in the course of it, I said that I had given those papers to the Secretary-General's Office at 10.30 a.m. that day. Unfortunately, the Officers of the Secretariat on the floor, here at the Table, said that they had not received those papers. A series of allegations were made against me that I have told a lie. Subsequently, Mr. Speaker, Sir, I stand by it and I request you for the sake of my reputation to correct the record.

MR. SPEAKER : It is a fact that your letter, along with the documents, was received in my Office. I say this just to put the record straight. I hope, this satisfies you.

DR. SUBRAMANIAN SWAMY : Thank you very much.

You made allegations.

SHRI MADHUKAR SIRPOTDAR (Mumbai North-West): You are a. . . \*\* person.

[Translation]

DR. SUBRAMANIAN SWAMY : You should. . . .\*\*

SHRI MADHUKAR SIRPOTDAR : No other person but you should. . . . (Interruptions)

[English]

DR. SUBRAMANIAN SWAMY : You are proud of the LTTE. You should be. . .\*\* of yourself. . .(Interruptions)

\*\*Expunged as ordered by the Chair.

MR. SPEAKER : Nothing will go on record.

(Interruptions)\*

MR. SPEAKER : Hon. Members, please take your seats.

#### (Interruptions)

MR. SPEAKER : Nothing will go on record except what Shri Sudip Bandyopadhyay says.

#### (Interruptions)\*

SHRI SUDIP BANDYOPADHYAY (Calcutta North-West) : I rise to raise a matter of privilege against Kumari Mayawati, an hon. Member of this House. I will just go through the contents of the letter which I have written to you.

MR. SPEAKER : Shri Bandyopadhyay, you have given a notice.

(Interruptions)

[Translation]

MR. SPEAKER : Please take your seat.

(Interruptions)

[English]

MR. SPEAKER : You have given a notice for privilege. It is under my consideration. Please take your seat.

SHRI SUDIP BANDYOPADHYAY : Can I explain it ?

MR. SPEAKER : It is under my consideration. Please take your seat.

SHRI SUDIP BANDYOPADHYAY : I Should explain it.

MR. SPEAKER : The notice that you have given is under my consideration. Please take your seat.

#### (Interruptions)

MR. SPEAKER : Nothing will go on record except what Shri Muthiah says.

(Interruptions)\*

11.04 hours

At this stage, Shri Akbar Ahmad came and stood on the floor near the Table.

MR. SPEAKER : Hon. Member, please go back to your seat.

(Interruptions)

\*Not recorded.

11.04½ hrs.

At this stage, Shri Akbar Ahmad went back to his seat.

MR. SPEAKER : Shri Bandyopadhyay, I have received your notice. It is under my consideration. Please take your seat.

# (Interruptions)

## [Translation]

SHRI VIJAY GOEL (Chandni Chowk) : I have also given a notice regarding breach of privilege. I wish that hon'ble speaker should give his ruling on it.. . . (Interruptions)

# [English]

MR. SPEAKER : Hon. Members, please take your seats. What is this ?

#### (Interruptions)

SHRI R. MUTHIAH (Periyakulam) : Mr. Speaker, Sir, with great mental agony and without peace of mind – which is there for the last four days – I am raising here an important issue. . . . (Interruptions)

MR. SPEAKER : Hon. Members, please take your seats. What is this ?

#### (Interruptions)

SHRI R. MUTHIAH : With great mental agony, I am raising this issue for your consideration. . . . (Interruptions)

MR. SPEAKER : I have allowed Shri Muthiah to speak and not you.

#### (Interruptions)

SHRI R. MUTHIAH : Sir. on 17.4.99 when the voting on the confidence motion was taking place here, I had voted against that motion, sitting in my seat, pressing the red button as well as the control button. It was promptly reflected from the display board also, that is, against my division number 101, a red light was glowing. All along – from the first bell onwards even after the second bell, when the entire process was taking place on that day – a red light was there against my division number. That indicates that I had voted against the motion on that day. But I do not know what had happened to the computer paper. . . . (Interruptions)

SHRI T.R. BAALU (Madras South) : He could have corrected it through the slip. . . .(Interruptions)

SHRI R. MUTHIAH : Sir, I have been told that it had been recorded as 'no' vote against my division number 101. As far as this House and the hon. Members are concerned, if proper signal is there on the display board, that indicates that the Member had voted promptly. . . . (Interruptions)

MR. SPEAKER : It is the personal explanation of the hon. Member, Please take your seat.

# [Translation]

SHRI PRABHU DAYAL KATHERIA (Ferozabad) : It is not so. . . . (Interruptions) Voting should be held again. . .(Interruptions)

## [English]

SHRI R. MUTHIAH : It is my privilege.

Had there been no red signal against my division number in the display board, I would have asked for a slip and voted through that slip. Since promptly a red light was there against my division number, I did not do it. . . . (Interruptions)

SHRI T.R. BAALU : He had put the slip in his pocket.

SHRI R. MUTHIAH : That is what I am coming to.\*I had never asked for a slip and the staff also never gave a slip to me. But in some of the vernacular papers in Tamil Nadu as well as in the Sun TV, they are propagating an. . .\* throughout Tamil Nadu that I had got a slip from the staff, put in in my pocket and gone away from here. How is it possible ? A red light was there; neither did I ask for a slip nor did they give one to me. So, that question does not arise when a red light was there on the display board. . . .(Interruptions)

SHRI T.R. BAALU : You have to enquire into this. . . . (Interruptions)

SHRI R. MUTHIAH : Video clippings would have been taken on that day. I think, you would have gone through the video clippings. . . . (Interruptions)

MR. SPEAKER : Please conclude.

#### (Interruptions)

SHRI R. MUTHIAH : From that video clippings, one can see that a red light was glowing all along against my division number 101. . . . (Interruptions)

SHRI T.R. BAALU : Sir, you may appoint a committee to enquire into this. . . .(Interruptions)

MR. SPEAKER : Shri Baalu, I have allowed him. Please take your seat. He is giving his personal explanation. Please allow him. . . . (Interruptions)

SHRI R. MUTHIAH : So, I have voted against the motion. In this context, I appeal to you because it involves my integrity and loyalty to the party as well as to my constituents. . . . (Interruptions)

\*Expunged as ordered by the Chair.

MR. SPEAKER : Please conclude.

SHRI R. MUTHIAH : Hence, I request you and appeal to you. . . . (Interruptions)

MR. SPEAKER : Okay.

MR. SPEAKER : Shri Baalu, please take your seat. Shri Muthiah, please conclude.

SHRI R. MUTHIAH : Sir, at that time, a red light was glowing against my division number and you can go through the video clippings also. . . . (Interruptions)

MR. SPEAKER : Hon. Members, please take your seats. What is this ?

#### (Interruptions)

SHRI T.R. BAALU : Sir, you may appoint a committee to enquire into this. . . . (Interruptions)

SHRI R. MUTHIAH : Sir, you can see that I had voted against the motion. . . . (Interruptions)

MR. SPEAKER : Please go to your seats. I have allowed Shri Muthiah to speak.

#### (Interruptions)

MR. SPEAKER : Hon. Members, this is not good. Please go to your seats.

#### (Interruptions)

SHRI R. MUTHIAH : Sir, even today *The Indian Express* has gone on record saying that I have got a slip from the staff and put it my my pocket; without putting it in the ballot box here I had gone away. . . . *(Interruptions)* Sir, is there a system like this in this House ? Is there a ballot box here ?. . *(Interruptions)* I would like to clarify my position. . . *(Interruptions)*. I have voted against the Motion which was very well reflected on that day against my Division No. 101. There was an indication that I had voted against the Motion. Sir, you have to kindly clarify and protect my interests. . . *(Interruptions)* 

MR. SPEAKER : Shri Muthiah, please conclude.

#### (Interruptions)

SHRI R. MUTHIAH : Sir, you are the custodian of the House. Outside the House so much harm has been done against my interests and to my future career itself. That is why I am appealing to you to kindly clarify the position. . . . (Interruptions) THE MINISTER OF POWER, MINISTER OF PARLIAMENTARY AFFAIRS AND MINISTER OF NON-CONVENTIONAL ENERGY SOURCES (SHRI P.R. KUMARAMANGALAM) : Sir, I do understand the hon. Member's problem. It is an extremely embarrassing situation. I do understand that according to the procedures, there are enough counter-checks. I do understand that the photograph is normally taken of the voting pattern of the lights. I also do know that under the procedure computer also records the same. If there is a lapse at one place, then it can be verified at other place. I request the Secretariat to look into the matter because the hon. Member is embarrassed by all sorts of campaign. .(Interruptions)

MR. SPEAKER : Shri Muthiah, I have received your representation also apart from your raising the matter in the House. You are aware that you have also met me and represented the matter personally. I have directed that a detailed scrutiny of the matter may be made by the Secretariat. The scrutiny is going on.

I hope to come back to you in a quick time.
