

Allotment of Petrol and CNG Pumps

3077. SHRI PRINCE RAJ:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the number and percentage of existing petrol pumps, CNG pumps and LPG agencies allotted to the persons belonging to SC, ST, OBC and General categories, OMCs and State/UT-wise;
- (b) the number of cases of allotment of petrol pumps, CNG pumps and LPG agencies to SCs, STs and OBCs are pending at various stages during the period from 2014 to 2023, Stage, OMCs, States/UT and year-wise;
- (c) the details of reservation roster, vacancy and backlog vacancy for allotment of petrol pump, CNG pump and LPG agency, State/UT, OMCs and category-wise;
- (d) the efforts being made by the Government/ OMCs to fill up the quota and backlog of SC, ST and OBC categories as per reservation policy and the time by which the said allotment is likely to be made;
- (e) whether the States are not providing land for petrol pumps to SC/ST applicants, particularly in Bihar, Uttar Pradesh and Delhi; and
- (f) if so, the steps taken/being taken by the Government to provide land to SC/ST applicants?

(a) to (c) : Public Sector Oil Marketing Companies (OMCs) have informed that expansion of Retail Outlet (RO) network is a continuous process to ensure adequate availability of motoring fuels such as petrol and diesel throughout the country. OMCs have advertised 49960 locations in June/July 2023 for setting up of ROs across the country including locations reserved for SC, ST and OBC categories. The number of locations advertised also include backlog locations for SC/ST category.

Appointment of LPG distributorships is also a continuous process and the locations for setting up of LPG distributorships are identified based on sale potential that makes them commercially viable. However, it is constantly ensured that the reservation is maintained on cumulative basis, by respective PSU OMCs

evenwhen de-categorization of the locations is done from earlier roster by converting corresponding number of LPG Distributorship locations under 'Open' category from the new roster to 'SC/ST' and 'OBC' category, as applicable.

Establishment of CNG stations is part of development of City Gas Distribution (CGD) Network and the same is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB), which do not reserve allocation by category.

Public Sector Oil Marketing Companies (OMCs) have implemented new "Dealership Selection Guidelines" for Retail Outlets (ROs) w.e.f. 28.06.2023 and "Unified Guidelines for Selection of LPG Distributorships" w.e.f. 23.06.2016. Both these guidelines inter-alia, have a provision of 22.5% reservation for SCs/STs and 27% reservation for OBCs in allotment of retail outlet dealerships and LPG Distributorshipsexcept in the following States :

PSU OMCs (IOCL, BPCL, HPCL)/State/UT-wise number and percentage of existing ROs and LPG Distributorships allotted to SC, ST, OBC and General Categories are given in **Annexure-1** and **Annexure-2**.

PSU OMCs have further informed that setting up of RO and LPG distributorships where Letter of Intent (LOI) have been issued involve various stages which includes obtaining necessary statutory approvals, construction at site etc. All efforts are made to expedite the process of commissioning of RO and LPG Distributorships.

During the period 2014 to 2023 (as on 01.10.2023), PSU OMCs have commissioned 30,394 ROs and 12,308 LPG distributorships under SCs, STs, OBCs and General category in the country. During the said period, 15,071 LOIs for ROs and 169 LOIs for LPG distributorships issued by PSU OMCs to SCs, STs, OBCs and General Category are pending for commissioning. PSU OMCs (IOCL, BPCL, HPCL)/State/UT-wise number of such LOIs for ROs and LPG distributorships by category from 2014 to 2023 are given in **Annexure-3** and **Annexure-4**.

(d) : The efforts made by PSU OMCs to fill up the quota in allotment of ROs to the reserved categories are as below :-

- (i) The application fees and Security Deposit for SC/ST & OBC applicants are kept lower than that for Open Category.
- (ii) SC/ST applicants are only required to identify suitable land, within the advertised stretch and offer the land to PSU OMC for purchase or for long term lease.
- (iii) ROs under SC/ST category are developed under Corpus Fund Scheme where the entire infrastructure of the retail outlet is developed by OMCs.
- (iv) SC/ST LOI holders are offered working Capital loan after the commissioning of the retail outlet.
- (v) Liquidation of pending SC/ST LOIs by giving one-time option to arrange land at a place of their choice anywhere in the country, subject to the offered land meeting techno-commercial viability and divestment of temporary COCOs through online process for handing over to pending LOI holders of SC/ST. This scheme was applicable till 31.3.2022.

(e)&(f) The question of States not providing land for petrol pumps to SC/ST applicants does not arise as currently SC/ST applicants are only required to identify suitable land, within the advertised stretch and the offered land by SC/ST candidates is taken on lease/purchased by the PSU OMCs for setting up of the ROs.
