- (a) the amount of funds released for the State of Maharashtra during each of the last five years under Rashtriya Krishi Vikas Yojana (RKVY);
- (b) the details of the programmes being run under this Yojana;
- (c) whether the objectives of the said yojana have been achieved; and
- (d) if so, the details thereof?

(a) & (b): The following programmes are implemented under Rashtriya Krishi Vikas Yojana (RKVY).

- i. Per Drop More Crop
- ii. Sub-Mission on Agriculture Mechanization
- iii. Soil Health and Fertility
- iv. Paramparagat Krishi Vikas Yojna
- v. Rain Fed Area Development
- vi. Agro Forestry
- vii. Crop Diversification Programme
- viii. RKVY- Detailed Project Report (DPR) component

The year wise status of fund released to the State Government of Maharashtra under various programmes of RKVY during the last five years is given at Annexure-I.

(c) & (d): Yes. As per the report submitted by State Government of Maharashtra, the following interventions have been done under scheme:

(i) Pre and post-harvest facilities like Protected cultivation, Lining of farm pond, Construction of well, Mechanization, Low cost onion storage structure and godowns are provided.

(ii) The state has utilized the flexibility to plan projects as per its need.

(iii) Public Private Partnership (PPP) projects are implemented for increasing farmers' income.

(iv) Risk of farmers is mitigated through, storage structures, post-harvest structures, Animal husbandry projects.

(v) National priorities are met through projects like Reclamation of problematic soils, Accelerated fodder development projects, foot and mouth disease.

More than 1160 custom Hiring Centers, 30 High Tech Hubs and more than 192 Village Farm Machinery Banks established for making available the machines and equipment to the farmers on rentals. Integrated farming system have been implemented in 0.233 hector area and Drip and Sprinkler irrigation facilities are installed for more than six lakh hector area. More than 11 lakh tree have been planted to encourage and expand tree plantation on farm land.
