Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of works done under Jal Jeevan Mission-Urban (JJM-U) in Andhra Pradesh during the last three years;**
- (b) the amount sanctioned, allocated and spent for these works during the last three years;**
- (c) the number of houses in which tap water has been supplied under JJM-U in Andhra Pradesh; and**
- (d) the steps being taken to ensure the availability of tap water at every household at the earliest?**

(a): The proposed Jal Jeevan Mission Urban scheme has been launched as Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 for a period of 05 years i.e. from the financial year 2021- 22 to 2025-26. The mission aims at making the cities 'water secure' and provide universal coverage of water supply through functional taps to all households in all the statutory towns in the country. Mission also aims at providing sewage/ septage management to all households of 500 cities covered in first phase of the AMRUT scheme.

In Andhra Pradesh, 552 projects worth ₹8,517.69 crore have been approved by Ministry of Housing & Urban Affairs (MoHUA) under AMRUT 2.0 so far, which include 269 Water Supply projects worth ₹5,268.19 crore, 87 Sewerage Septage Management projects worth 2,727.46 crore & 196 Water Body Rejuvenation projects worth ₹522.04 crore. As reported by the state, Detailed Project Reports (DPRs) for 287 projects worth ₹3,341.81 crore have

been approved, out of which, Notice Inviting Tender (NITs) of 262 projects worth ₹2,622.39 crore have been issued. Out of 212 projects worth ₹797.90 crore for which contracts have been awarded, 10 projects worth ₹51.26 crore have been completed.

(b): The funds under AMRUT 2.0 are released to States/Union Territories (UTS), State Water Action Plan-wise respectively and not project-wise. Funds released and Utilization Certificate (UC) received in last 3 Years under AMRUT for projects is as under:

(c) & (d): AMRUT 2.0 covers all the statutory towns of the country to ensure universal coverage of water supply & make cities 'water secure'. 10.60 lakh new tap connections have been proposed through the approved projects in Andhra Pradesh till date under AMRUT 2.0.

However, under AMRUT, State has informed that 4.20 lakh water tap connections are provided under AMRUT & in convergence in the State of Andhra Pradesh.
