Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of beneficiaries of Pradhan Mantri Matru Vandana Yojana alongwith its present state of implementation in the State of Tamil Nadu, districtwise:
- (b) the details of funds released by the Government under the Yojana, during the last three years, State/UT-wise;
- (c) whether the Government provides sufficient funds to States under the Yojana and if so, the details thereof;
- (d) the challenges faced by the Government while implementing the Yojana, and
- (e) whether the Government plans for increasing the amount of Direct Benefit Transfer to the beneficiaries of the scheme, if so, the details thereof, and if not, the reasons therefor?

ANSWER

MINISTER FOR WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

(a) The Pradhan Mantri Matru Vandana Yojana (PMMVY) is a Centrally Sponsored Maternity Benefit Scheme under which cash incentives of ₹5,000/- is provided directly to the Bank/Post Office account of the beneficiary in Direct Benefit Transfer (DBT) mode for the first child. The eligible beneficiaries receive the remaining cash incentive, as per approved norms towards maternity benefit under Janani Suraksha Yojana after institutional delivery, so that on an average a woman gets ₹6,000/-. Cash incentive of ₹6,000/- is also provided under PMMVY to eligible beneficiaries for second child subject to the second child being a girl.

Under PMMVY, more than 3.96 crores beneficiaries have been enrolled since inception of the Scheme in 2017-18 and till 30.06.2024. Further, maternity benefits of more than ₹15,401 crores (includes both Central and State share) have been disbursed to more than 3.44 crore beneficiaries during the aforesaid period.

The district-wise details of number of beneficiaries enrolled under PMMVY in Tamil Nadu since inception of the scheme and till 18.07.2024 is at **Annexure-I**.

- (b) & (c) Sufficient funds have been released to States/UTs for implementation of PMMVY upon completion of State Nodal Agency (SNA) compliances by States/Union Territories. The State/UT-wise details of Central share of funds released during the last three years under PMMVY is at **Annexure-II**.
- (d) & (e) PMMVY is being implemented through State Governments/UT Administrations. No major challenges have been faced by the Ministry in implementing the scheme. In order to ensure proper implementation of PMMVY in States/UTs, the Ministry of Women and Child Development handholds all States/UTs on issues related to Pradhan Mantri Matru Vandana Yojana portal; facilitates scheme implementation by supporting, planning and monitoring activities associated with the technology based solutions; developing Information Education and Communication (IEC) plans, training modules, capacity building of Accredited Social Health Activist (ASHA), Auxiliary Nurse and Midwife (ANM) and Anganwadi Workers (AWWs).

No proposal to increase the amount of maternity benefit under PMMVY is under consideration in the Ministry.
