Will the Minister of Women and Child Development be pleased to state:

- (a) the details of the objectives of setting up One Stop Centres (OSCs);
- (b) the budgetary norms for construction of OSC;
- (c) the number of OSCs operational as on date, specially in Maharashtra, Gujarat and Odisha indicating the number of persons benefitted therefrom;
- (d) the number of OSCs proposed to be set up specially in Tripura, Jharkhand, Rajasthan and Maharashtra;
- (e) whether the Government proposes to conduct social audit on the OSC as tool of self-assessment to evaluate the efficiency and quality of service provided; and
- (f) the list of total number of patients who availed OSC services in the country, State-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

(a) The objectives of setting of One Stop Centres (OSCs) are to provide integrated support and assistance under one roof to women affected by violence and in distress both in private and public spaces and facilitate immediate emergency and non-emergency access to a range of services including medical, legal, temporary shelter, police assistance, psychological and counselling support to fight against any forms of violence against them.

- (b) The budgetary norms for construction of One Stop Centre are based on CPWD 2020 rates to the tune of Rs.60.00lakh (Tentative) for Delhi and National Capital Region. The rates for other regions/locations is as per the Schedule of Rates (SOR) of the States/UTs concerned. A variable cost @5% of the construction cost to meet any variation in the construction cost is also provided.
- (c) As on date, 785 OSCs are operational across the States/UTs. The number of OSCs operational, as on date, in Maharashtra, Gujarat and Odisha indicating the number of women benefitted therefrom is as under:-

- (d) As the scheme is demand driven by the States and UTs, they are encouraged to set-up One Stop Centre in those districts having higher rate of crime against women or those having bigger geographical area, preferably in aspirational districts. Further, as and when a proposal for setting up OSC is received from the States/UTs, the same is considered by Programme Approval Board (PAB) of the Ministry.
- (e) No social audit has been conducted for OSCs. However, a third party evaluation of the schemes of the Ministry, including One Stop Centre (OSC) Scheme, was conducted during the Financial Year 2020-21 through NITI Aayog. The study found the relevance, effectiveness and sustainability of the scheme as satisfactory.
- (f) The details of total number of women assisted through OSC services in the country, State-wise are given as under:
