NO. 1807. MRS RUCHI VIRA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government has prepared any action plan for the development of smart cities in the country during the last ten years and if so, the details thereof;**
- (b) the details of the funds allocated for the development of smart cities during the said period, State/UT-wise, particularly for Moradabad smart city in Uttar Pradesh; and**
- (c) the details of the works for which the allocated funds for Moradabad smart city have been spent?**

**ANSWER
THE MINISTER OF STATE IN THE

- (a) Government of India launched the Smart Cities Mission (SCM) on 25th June, 2015. 100 Smart Cities were selected through a two-stage challenge process in 4 rounds of competition between January, 2016 and January, 2018. Each Smart City, at the time of selection, prepared a Smart City Proposal (SCP) containing its vision, resource mobilization plan, and intended outcomes in terms of infrastructure up-gradation and smart applications. Consultations with stakeholders, including citizens were held during the preparation of the SCPs. As per SCM Guidelines, Central Government is to provide financial support to the extent of ₹48,000 crore to 100 Cities under SCM i.e., on an average of ₹ 500 crore per city. An equal amount on a matching basis is to be contributed by the State Government / Urban Local Body (ULB) other than in North-east / hilly States where the ratio is 90:10.**

(b) The details of the funds allocated for the development of smart cities during the said period, State/UT-wise, including Moradabad Smart City is at Annexure-I.

(c) The details of the works for which the allocated funds for Moradabad smart city have been spent is at Annexure-II
