PM VISHWAKARMA YOJANA

1820. DR. K SUDHAKAR:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government has data regarding the total number of enrollments made under PM Vishwakarma Yojana across the country and if so, the details thereof, State-wise;
- (b) the details of the total number of people being benefited under PM Vishwakarma Yojana in Chikkaballapur Lok Sabha Constituency of Karnataka;
- (c) the details of the initiatives taken under the said yojana for Karnataka;
- (d) the details of the support granted under the Assistance to Training Institutions scheme for Karnataka; and
- (e) whether the Government has data regarding the Khadi industry of Karnataka and if so, the details thereof including the details of total production, employment generated and profit made during the financial year 2023-24?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a) to (c): The PM Vishwakarma Yojana was launched by the Hon'ble Prime Minister on 17.09.2023. The Scheme aims to provide end-to-end support to artisans and craftspeople who work with their hands and tools. The Scheme components include recognition through PM Vishwakarma Certificate and ID Card, Skill Upgradation, Toolkit Incentive, Credit Support, Incentive for Digital Transactions, and Marketing Support. The Scheme has been rolled out across the country, including in Karnataka State. The State/UT-wise total number of enrolments made under the Scheme is at **Annexure-I**. The total number of applications received and successful registrations from Chikkaballapur district, eligible to avail the benefits under PM Vishwakarma Scheme, are **97,356** and **17,696** respectively.
- (d): Ministry of Micro, Small and Medium Enterprises is implementing a central sector scheme namely "Assistance to Training Institutions (ATI)" Scheme under which financial support is provided for (i) strengthening of overall capacity of training institutions of Ministry of MSME and State level existing EDIs and (ii) skill development training programmes. The Scheme is demand driven. The total funds released under ATI Scheme during the last three years and the current year (as on 26.07.2024), across the country are as follows: -

(e): In Karnataka State, the total production under Khadi Industry during the FY 2023-24 is Rs.49, 943.44 lakhs and the employment generated is 27,612 persons. Khadi programme is being implemented by registered Khadi Institutions which are non-profit making organisations.
