Will the Minister of Women and Child Development be pleased to state:

- (a) the number of One Stop Centres (OSCs) setup in the country till date, State/UT-wise and year-wise;
- (b) the details of the measures undertaken, if any, to adequately train staff at these Centres;
- (c) whether Government has any plan to conduct social audit of the OSCs as tool of self-assessment to evaluate the efficiency and quality of service provided;
- (d) if so, the details thereof;
- (e) whether OSC initiative has helped bridge the gap between women reaching out for help seeking assistance and those actually receiving the same, if so, the details thereof; and
- (f) the steps/plan to enhance outreach and awareness about these centres to ensure that more women utilize their services?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI ANNPURNA DEVI)

- (a) The State/UT-wise number of One Stop Centres (OSCs) setup in the country is placed at **Annexure-I** and year-wise number of One Stop Centres (OSCs) setup in the country is placed at **Annexure-II**.
- (b) The Ministry of Women and Child Development has organised three regional training programmes at Regional Centres of National Institute of Public Cooperation and Child Development (NIPCCD) at Guwahati, Indore, and Bangalore and two National Workshops at Vigyan Bhawan, New Delhi to standardize capacity building of staff of One Stop Centres. Expert resource persons from National Institute of Mental Health and Neurosciences (NIMHANS), NIPCCD, National Legal Services Authority (NALSA), National Informatics Centre (NIC) and international organisations

such as United Nations Population Fund (UNFPA) have been engaged for facilitating technical sessions in their respective fields.

- (c) and (d) A third party evaluation of the schemes of the Ministry, including One Stop Centre (OSC) Scheme, was conducted during the Financial Year 2020-21 through NITI Aayog. The study found the relevance, effectiveness and sustainability of the scheme as satisfactory.
- (e) The One Stop Centre (OSC) scheme is being implemented by the Government since 1st April, 2015 to provide integrated support and assistance under one roof to women affected by violence and those in distress, both in private and public spaces. The OSCs also provide an integrated range of services including medical aid, legal aid and advice, temporary shelter, police assistance, psycho-social counselling to needy women. Since inception till 31st May 2024, more than 9.19 lakh women have been assisted through these OSCs across the country.
- (f) As per Mission Shakti Guidelines, the overall implementation of the Scheme at State/UT level is being done by the Department of Women and Child Development/ Social Welfare Department of the States/ UTs concerned. Further, under SANKALP Hub for Empowerment of Women (HEW), public awareness and campaigns related to women centric schemes including the One Stop Centre scheme are undertaken.
