OBJECTIVE OF PM-SYM

2135. SHRI TEJASVI SURYA:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) the objective of the Pradhan Mantri Shram Yogi Man-dhan (PM-SYM) scheme;**
- (b) the details of expenditure and implementation of the PM-SYM so far;**
- (c) the details of unorganized workers enrolled so far under the PM-SYM scheme, State-wise and particularly in the State of Karnataka;**
- (d) the details of the funds allocated for this scheme during each of the last three years and amount utilized and reasons for the low utilisation of allocated funds, if any; and**
- (e) whether the Government has taken any other steps to enroll more unorganised workers in the scheme, if so, the details thereof?**

ANSWER

**MINISTER OF STATE FOR LABOUR AND EMPLOYMENT
(SUSHRI SHOBHA KARANDLAJE)**

(a) to (e): The Pradhan Mantri Shram Yogi Maan-dhan (PM-SYM) scheme was launched in February, 2019 in order to provide old age protection to the workers of unorganised sector in age group of 18 to 40 years. This is a voluntary and contributory pension scheme.

The number of unorganized workers enrolled so far under PM-SYM scheme are around 50.15 lakh (including bulk registration of around 5 lakhs) as on 30-07-2024.

Total numbers of beneficiaries under the PM-SYM Yojana in the State of Karnataka are 1,42,067. The state-wise detail is annexed.

The scheme is demand-driven and budget utilized is as per demand. The details of funds allocated for scheme during each of the last three years and the amount utilized of the allocated funds are as under:

Year	Fund Allocated in Budget (Rs. in crore)	Expenditure (Rs. in crore)
2021-22	400	324.23
2022-23	350	269.91
2023-24	350	162.51

All the State/UT Governments have been requested to popularize the scheme and mobilize the target groups/eligible workers for enrolment under the PM-SYM scheme. Most of the States/UT Governments have extended the support in implementation of PM-SYM Scheme and taken effective steps to mobilize the unorganised workers. The Central Government has also taken several initiatives to increase the enrolment under PM-SYM Scheme such as periodic reviews of the progress of the scheme with States/UTs, and publicity of the scheme through IEC activities.
