- (a) the total amount of funds released from Compensatory Afforestation Fund Management and Planning Authority (CAMPA) to Mahasamund, Dhamtari and Gariaband Districts of Mahasamund Parliamentary Constituency in the State of Chhattisgarh;
- (b) the details of the works for which the said amount of funds have been utilized; and

(a) to (c) The Compensatory Afforestation Fund Act, 2016 aims to compensate the loss of forest & ecosystem services due to diversion of forest land as per the provision of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. The afforestation and forest conservation works and activities are carried out as per the provisions of the Compensatory Afforestation Fund Act, 2016 and Rules thereunder. The CAMPA funds are utilised for mandatory activities of compensatory afforestation, catchment area treatment plan, integrated management of wildlife habitat etc. In addition, works for improvement of quality of forests, rehabilitation of degraded forests, enrichment of biodiversity and improvement of wildlife habitat, soil and moisture conservation, forest protection, fire prevention and control etc. are undertaken.

As per the information received from the State of Chhattisgarh, the details of State Compensatory Afforestation Fund (State CAMPA fund) released to Mahasamund, Dhamtari and Gariaband Districts of Mahasamund Parliamentary Constituency during the year 2018-19 to 2024-25 is given below:-
