### DEVELOPMENT OF HANDLOOM AND HANDICRAFT SECTORS

## 2394. SHRI G M HARISH BALAYOGI:

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

(a) the details regarding the schemes/projects/initiatives undertaken by the Government for the development of Handloom and Handicraft sectors in the rural areas, over the last five years, State-wise, especially in Andhra Pradesh;

(b) the details regarding the amount of funds allocated and utilized under these schemes, over the last five years, State-wise, especially in Andhra Pradesh;

(c) the details regarding the number of beneficiaries especially women under these schemes/projects/initiatives undertaken by the Government for the development of Handloom and Handicraft sectors in the rural areas, over the last five years, State-wise, especially in Andhra Pradesh; and

(d) whether the Government has any plans/is planning to implement any schemes for the development of Handloom and Handicraft sectors especially targeted towards SC/ST/OBC communities?

# उत्तर

## ANSWER वस्त्र राज्य मंत्री (**श्री पबित्र मार्घेरिटा**) THE MINISTER OF STATE FOR TEXTILES (SHRI PABITRA MARGHERITA)

(a) & (b): The Government of India, Ministry of Textiles is implementing following schemes for the development of handloom and handicraft sectors across the country, including rural areas and Andhra Pradesh:

- 1. National Handloom Development Programme;
- 2. Raw Material Supply Scheme;
- 3. National Handicraft Development Programme;
- 4. Comprehensive Handicrafts Cluster Development Scheme;

Under the above schemes, financial assistance is provided for raw materials, purchase of looms, accessories and toolkits, design innovation, product diversification, infrastructure development, marketing of handloom and handicraft products in domestic and overseas markets, loans at concessional rates, etc.

In the schemes implemented by the Ministry of Textiles in these sectors, budget is not allocated State/UT-wise. Funds to eligible handloom agencies are released for various interventions on receipt of viable proposals as per the extant guidelines of the respective schemes. The details of funds released and utilised under these schemes during the last five years are as follows:

(c) & (d): Women and SC/ST/OBC weavers/artisans play a vital role in the handloom and handicraft sector. In order to encourage them, the Ministry of Textiles provides additional incentives to them to sustain and augment their business. Some of the benefits provided to the women and SC/ST/OBC weavers/artisans across the country including Andhra Pradesh are:

- Under schemes of handloom and handicrafts sector, preference is given to programmes which have weavers/artisans from women/SC/ST/OBC category.
- There is 100% subsidy to BPL/SC/ST/Women/Transgender/Differently-abled weavers for construction of work sheds under National Handloom Development Programme.
- Since 2016, Kamladevi Chattopadhyay Award has been instituted specifically for women weavers.

Details regarding State-wise number of beneficiaries including women/SC/ST/OBC weavers/artisans under schemes of Handloom and Handicraft sectors during the last five years are given at Annexure-I.
