## Forest Cover in Haryana

#### 28. SHRI VARUN CHAUDHRY:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the reasons for delay in publication of India State of Forest Report 2023;
- (b) the status of Forest Cover in the State of Haryana since 2019 and its ranking amongst all the States;
- (c) the step taken to increase the forest cover in the said State and the funds allocated during the last five years; and
- (d) the details of any special initiatives under consideration to increase the forest cover in the said State?

### **ANSWER**

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI KIRTI VARDHAN SINGH)

- (a) As per the information received from Forest Survey of India (FSI), Dehradun, the reason for delay in publication of India State of Forest Report 2023 is due to inclusion of 751 districts in the report instead of 636 districts included earlier.
- (b) Forest Survey of India (FSI), Dehradun, an organization under the Ministry carries out the assessment of forest cover biennially and the findings are published in India State of Forest Report (ISFR). The status of forest cover in the State of Haryana since 2019 and its ranking amongst all the States is as follows:-

(c) & (d) To increase the forest cover, the Ministry supports the States/Union Territories for carrying out afforestation activities mainly through National Mission for a Green India (GIM) and Nagar Van Yojana Further, afforestation activities are also undertaken by utilizing the Compensatory Afforestation Fund as per the provisions of the Compensatory Afforestation Fund Act, 2016 and the Rules made there under.
