(c) the details and the number of routes cancelled by airlines; and

(d) the details of budget allocated and utilised under UDAN scheme along with the subsidy provided to the airlines for operations since inception of the said scheme, year-wise?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (Shri Murlidhar Mohol)

(a)&(b): Under Regional Connectivity Scheme - Ude Desh ka Aam Naagrik (RCS-UDAN), 870 valid routes have been awarded out of which 579 routes, connecting 85 unserved/underserved airports (13 heliports and 02 water aerodromes), have been operationalised.

(c): 106 routes were discontinued by the airlines before completion of the 03 year tenure under the Scheme. ;

(d): Rs. 4500 crore has been allocated for revival/upgradation of unserved and underserved Airports/Heliports/Water Aerodromes owned by Airports Authority of India (AAI) / State Governments / Central Public Sector Undertakings / Ministry of Defence under Phase I of the Scheme. Rs.1000 crore has been allocated in Phase-II of the scheme to revive additional airports, heliports, water aerodromes and advanced landing grounds during the period 2023-24 to 2025-26. An expenditure amounting to Rs. 4071.98 crore has been incurred so far. Rs. 3512.29 crore has been disbursed to the Selected Airline Operators towards Viability Gap Funding (VGF) as per the provisions of the Scheme. Details as per Annexure.
