DEATHS AND ACCIDENTS OF LABOURERS IN INDIA

66. KM. SUDHA R:

Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a)the number of labourers who have lost their lives in the organized sector over the last five years in the country, sector-wise, year-wise and district-wise for the State of Tamil Nadu;
- (b) the number of labourers who met with accidents in the organized sector over the last five years in the country, sector-wise, year-wise and district-wise for the State of Tamil Nadu;
- (c)the steps taken by the Government to prevent deaths and accidents of labourers in the country; and
- (d)whether it has led to a reduction in deaths and accidents of labourers in the country, if so, the details thereof?

ANSWER

MINISTER OF STATE FOR LABOUR AND EMPLOYMENT (SUSHRI SHOBHA KARANDLAJE)

- (a) & (b): The year-wise details of number of labourers suffering fatal and non-fatal accidents in the country including Tamil Nadu in registered factories and mines during last five years is at Annexures I and Annexure II respectively.
- (c) & (d): The Government has enacted the Factories Act, 1948 and the Mines Act, 1952 which provides for safety, health and welfare of workers working in the factories and mines respectively. The Factories Act, 1948 and rules framed thereunder are enforced by the respective State Governments through the Chief Inspector of Factories (CIFs) / Directorates of Industrial Safety and Health (DISH) in their respective sphere. CIFs / DISH are empowered to take legal action against the occupier and manager of the factory for violating the provisions of the Factories Act, 1948. The Mines Act, 1952 and rules and regulations framed thereunder are enforced by Directorate General of Mines Safety (DGMS). This has resulted in reduction in accidents and improving the occupational safety of workers.
