Students secured Full Marks in NEET

†124. SHRI OMPRAKASH BHUPALSINH ALIAS PAVAN RAJENIMBALKAR: MS. PRANITI SUSHILKUMAR SHINDE:

Will the Minister of EDUCATION be pleased to state:

- (a) whether it is a fact that NEET exam was conducted by the National Testing Agency on 05/05/24 at 4750 centers;
- (b) if so, the number of students who got 720/720 marks in the examination along with the details thereof;
- (c) whether grace marks were awarded in the aforesaid exam;
- (d) if so, the number of students awarded grace marks along with the details thereof;
- (e) whether it is a fact that an illegal way was adopted in this examination;
- (f) whether the Government has conducted any inquiry into it or is being investigated by any committee if so, the details thereof;
- (g) whether the UGC NET 2024 exam has been cancelled;
- (h) if so, the details thereof; and
- (i) the reason for cancelling this exam and the stringent steps taken by the Government to prevent such incidents?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF EDUCATION (DR. SUKANTA MAJUMDAR)

(a) to (f) The National Testing Agency conducted the NEET(UG) 2024 Examination on 5th May, 2024 at 4750 Centres. As per the result initially declared by NTA on 4th June, 2024, there were 67 candidates, who had secured 720/720 marks, which included 6 candidates who had got grace marks on the recommendation of the Grievance Redressal Committee (GRC) constituted by NTA. GRC looked into the grievances received from candidates who claimed to have suffered loss of time during the examination at few centres and recommended that they be compensated as per the formula/mechanism followed in the judgement dated 13.06.2018 of the Hon'ble Supreme Court in W.P 551 of 2018. Accordingly, grace marks were given to 1563 candidates.

However, the decision of NTA regarding grace marks was revisited by a High-Powered Committee constituted by NTA which recommended to conduct re-test for all 1563 candidates to whom grace marks were awarded. The same was placed before Hon'ble Supreme Court on 13.06.2024 in the case WP (Civil)No.336/2024 Jaripiti Kartheek Vs. National Testing Agency and Ors. Hon'ble Court observed the decision to conduct re-test to be fair, reasonable & justified.

The Re-test was held on 23/6/24 after the withdrawal of grace marks to such candidates. As per the final result declared on 30.6.24, 61 candidates have scored 720/720 marks, thus excluding 6 candidates from the initial number of 67.

(g) to (i) NTA conducted the UGC-NET June 2024 Examination in OMR (pen and paper) mode on 18th June, 2024 in two shifts across different cities of the country. On 19th June, 2024, the University Grants Commission (UGC) received certain inputs on the examination from National Cyber Crime Threat Analytics Unit of Indian Cyber Crime Coordination Centre (I4C) under the Ministry of Home Affairs. These inputs prima-facie indicated that the integrity of the aforesaid examination may have been compromised.

To ensure the highest level of transparency and sanctity of the examination process, the Ministry of Education, decided that the UGC-NET June 2024 Examination be cancelled. The matter was entrusted to CBI for thorough investigation. NTA has informed that the UGC-NET June 2024 Examination shall now be conducted between 21st August, 2024 and 4th September, 2024 in C.B.T. mode.

As a deterrence to unfair means in public examinations, the Central Government has enacted the Public Examination (Prevention of Unfair Means) Act 2024. This Act has come into force w.e.f. 21st June, 2024 and Rules have also been notified thereunder on 23rd June, 2024.
