DRINKING WATER PROJECTS IN RAJASTHAN

†*53. SHRI RAJKUMAR ROAT:

Will the Minister of JAL SHAKTI be pleased to state:

a) the details of the cost of drinking water projects approved by the Government in districts covered under the Fifth Schedule in the country during the last five years, State, year, number and projectwise;

b) the details of present status of the approved works in the said area, activity-wise;

c) whether the drinking water project approved for the scheduled areas during the last five years have not been practically implemented so far in Rajasthan; and

d) if so, the time by which these the said projects are likely to be implemented practically along with the details thereof, project-wise?

(a) to (d) A Statement is laid on the table of the House.

Statement referred to in reply to parts (a) to (d) in respect of Lok Sabha Starred Question No. *53 for reply on 25.07.2024 regarding drinking water projects in Rajasthan asked by Shri Rajkumar Roat

(a) & (b) Government of India is committed to make provision for safe & potable tap water supply in adequate quantity, of prescribed quality and on a regular & long-term basis to all rural households in the country. Towards this end, the Government of India launched the Jal Jeevan Mission (JJM), to be implemented in partnership with States/ UTs, in August 2019. JJM follows a universal coverage approach with a strong focus on service delivery to ensure parity in coverage. As such, significant progress has been made in the country since the launch of Jal Jeevan Mission, towards enhancing access to tap water to rural households. At the start of Jal Jeevan Mission in August 2019, only 3.23 Crore rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 23.07.2024, around 11.76 Crore additional rural households have been provided with tap water connections under JJM. Thus, as on 23.07.2024, out of 19.32 Crore rural households in the country, around 15 Crore (77.65%) rural households are reported to have tap water supply in their homes.

Further, under JJM district-wise details of individual projects/ schemes covered under the Fifth Schedule in the country, are not maintained at the Government of India level. However, State/ UT-wise details of tap water connections provided to rural households in ST majority areas in the country as on 23.07.2024 are at **Annex-I.**

(c) & (d) As informed by State Government of Rajasthan, total 20 drinking water projects were sanctioned during last five years for the scheduled areas in the State. Out of these 20 projects, work of 13 projects are in progress, 6 projects are under bidding process and 1 project is under financial sanction process. The details of these projects including the timeline for their likely completion are at **Annex-II.**
