SAGARMALA PROJECT PROPOSALS

*72. SHRI KRISHNA PRASAD TENNETI: SHRI Y S AVINASH REDDY:

Will the Minister of PORTS, SHIPPING AND WATERWAYS be pleased to state: पत्तन,पोत परिवहन और जलमार्ग मंत्री

(a) whether the Government has received any proposal from the Government of Andhra Pradesh and Visakhapatnam Port Trust for approval of 90 projects under the Sagarmala Project;

(b) if so, the details of each of the project proposals, estimated cost of the same, time-frame within which each project will be completed, details of execution and the steps taken by the Government so far on these proposals; and

(c) the details of the Budget allocation made/being made for each of the above projects in the financial years 2023-24 and 2024-25?

ANSWER

MINISTER OF PORTS, SHIPPING AND WATERWAYS (SHRI SARBANANDA SONOWAL)

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF LOK SABHA STARRED QUESTION NO.*72 ANSWERED ON 26TH JULY 2024 RAISED BY SHRI KRISHNA PRASAD TENNETI AND SHRI Y S AVINASH REDDY REGARDING "SAGARMALA PROJECT PROPOSALS".

(a) to (b) Ministry of Ports, Shipping and Waterways has received 29 new proposals worth around Rs. 3,300 Cr. from the Government of Andhra Pradesh. The details of the proposals are annexed. **[Annexure-I]**

Projects having high social impact but with no return or low Internal Rate of Return are being provided financial assistance under the Sagarmala Scheme of Ministry of Ports, Shipping and Waterways. Out of the 29 new proposals, Ministry has partially funded 4 projects worth Rs. 1,200 Cr. For projects related to development of Bhavanapadu Port, Ramayapatnam Port and Machilipatnam Port, Government of Andhra Pradesh has been requested to restructure the projects and explore the possibility of funding under Special assistance to States for Capital Investment under PM GatiShakti. Projects related to Coastal Berths and Fish Landing Centres (FLCs) have also been forwarded to the Ministry of Finance for their necessary approvals.

Currently, Ministry under Sagarmala Scheme is providing financial assistance to 13 projects worth around Rs. 2,500 Cr. in the State of Andhra Pradesh including Visakhapatnam Port Authority. These projects are related to Ro-Pax and Passenger Jetties, Fishing harbours, port modernization and skill development. Ministry has sanctioned Rs 450 Cr. for development of these projects. The list of projects funded under Sagarmala in Andhra Pradesh is provided at **Annexure-II**.

There are total 36 projects at a cumulative cost of Rs. 4,600 Cr undertaken by Visakhapatnam Port Authority & IWAI from their internal resources in the State of Andhra Pradesh. Out of these 36 projects, 22 projects worth ~Rs. 2530 Cr. are completed and 14 projects worth ~Rs. 2070 Cr. are under various stages of implementation and development. Astate of art International Cruise cum coastal Terminal at Visakhapatnam Port has been built to cater to the needs of passengers from around the world.

It may also be relevant to mention that, in the last decade, the nation's port capacity stood at ~2,500+ MTPA in 2022-23 (86% increase from 2014-15) and the cargo handling capacity at Major Ports has doubled.

Under the Sagarmala initiative, two Centre of Excellence in Maritime and Shipbuilding (CEMs) campuses have been set up in Mumbai and Visakhapatnam. Centre of Excellence in Maritime and Shipbuilding (CEMS) at Visakhapatnam, is the first of its kind in Asia, with 18 laboratories in Indian Maritime University Campus. The Institute has equipped over 10,000 students with employable engineering and technical skills.

(c) Sagarmala Programme is a flagship initiative of the Ministry of Ports, Shipping and Waterways to transform the country's maritime sector and unlock the untapped potential of extensive coastline, navigable waterways, and strategic maritime trade routes for port-led development and coastal community upliftment. The funds provided by Ministry of Finance are untied funds and not projects wise. Based on the approvals and project milestones, funds are released during the year. Under Sagarmala Programme, depending upon the needs of the project, financial obligations are met through PPP, equity participation and Grant-in-aid assistance. From Government side, there have been no funding constraints under the projects implemented through Sagarmala Scheme.
