Import of Banned Drugs

2076 SHRI RAMESH CHENNITHALA Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state :

(a) whether the drugs banned by WHO are being manufactured and used in India

(b) if so, the details thereof, and

(c) the reasons for not banning the use of such drugs in India?

THE MINISTER OF STATE OF THE MINISTRY OF CHEMICALS AND FERTILIZERS (SHRI SIS RAM OLA) : (a) to (c) As per the available information (upto 22.12.1995), World Health Organisation has so far reported the withdrawal of 44 drugs in some countries. Out of these 44 drugs, 26 drugs were never approved for marketing in India. Of the remaining 11 drugs were banned and 7 drugs were allowed for continued

marketing in the country with 'caution' by the Drugs Controller of India in consultation with experts and expert bodies like ICMR.
