#### Rail Line between Bhatinda and Kandla

2118. SHRI MAHESH KUMAR M. KANODIA: Will the Minister of RAILWAYS be pleased to state:

- (a) whether any survey has been conducted for laying rail line between Bhatinda and Kandla; and
  - (b) if so, the details therefor?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI SATPAL MAHARAJ): (a) and (b). Study for provision of a BG rail route from Bhatinda to Kandla was conducted in 1989-90. Based on this study, the work was included in the budget 1990-91. The work consisted of gauge conversion of Lalgarh-Bikaner-Merta Road-Jodhpur-Samdari-Bhildi, Patna-Chanasma-Pechraji and Viramgam and new line from Bhildi to Patan. Leter, when gauge converion of Delhi-Ahmedabad was started in 1992-93, it was decided to provide Kandla-Bhatinda BG rail route via Viramgam-Mehesana-Jodhpur-Bikaner-Bhatinda. Work on Lalgarh-Bikaner-Merta Road-Jodhpur has been completed and work on Jodhpur-Luni-Samdari-Bhildi-Mahesana-Viramgam is in progress and is targetted for completion within this financial year. With the completion of this work, there will be direct rail line from Bhatinda to Kandla.

The area increase programme are basically based on crop substitution, inter cropping, multiple cropping and replacement of uneconomic crops.
