(e) The targets of the remaining correspondence and other items of the programme will be the same as fixed in this Programme.

Construction of Rajghat Dam Project

2190. SHRI VISHWANATH SHA-RMA: Will the Minister of WATER RESOURCES be pleased to state:

(a) the present position of the construction of the inter-State Rajghat Dam Project;

(b) the details of cost-escalation resulting from delay in setting up the project; and

(c) the time by which it is likely to be completed?

THE MINISTER OF WATER RESOURCES (SHRI VIDYACHA-RAN SHUKLA): (a) The works on earth dam and masonry dam have been completed to the extent of about 92% and 80% respectively. Other miscellaneous works have been completed to the extent of about 68%.

(b) The project was originally (at 1979 price index) estimated to cost Rs. 123.22 erores. The estimated cost as revised in 1987 is Rs. 213.66 crores. The cost escalation is mainly due to rise in prices during construction period. The delay in completion of the project is mainly due to constraint of funds.

(c) The dam is scheduled for completion in June, 1993.

Propaganda Campaign against India by JKLF in the UK

2191. SHRI MUKUL WASNIK: Will the Minister of EXTERNAL AFFAIRS be pleased to state: (a) whether Jammu and Kashmir Liberation Front (JKLF) activists in the UK have been carrying on a propaganda campaign against India;

(b) if so, the details thereof;

(c) whether the Union Government are aware that some British Members of Parliament are pleading for their cause; and

(d) if so, the measures being taken by the Union Government in this regard?

THE MINISTER OF EXTERNAL AFFAIRS (SHRI MADHAVSINH SOLANKI): (a) Yes, Sir.

(b) From time to time they have been holding demonstrations and distributing pamphlets decrying alleged "Indian atrocities" on the Kashmiris and calling for an independent State of Jammu & Kashmir.

(c) Some British MPs have made statements in favour of a plebiscite/ referendum in Kashmir under UN resolutions.

(d) Our High Commission in London keeps in close and constant touch with British MPs from all parties, with the media and other influential opinion makers to explain our point of view. Some leading British MPs have also been invited to visit India.

Foreign Nationals in the Country

2192. SHRI C. K. KUPPUSWA-MY: Will the Minister of HOME AFFAIRS be pleased to state:

(a) the number of foreign citizens staying in India without proper documents; and

(b) the action taken or proposed to be taken by the Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMEN-TARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI M. M. JA-COB): (1) Some foreigners, mostly Pakistani and Bangladeshi Nationals, are reported to be overstaying/staying without proper documents in India.

(b) As and when any foreigner is detected for overstaying/staying without proper documents action under the Foreigners Act is taken by the State Governments/Union Territory Administrations to either prosecute him or deport him.
